Reporting Period – April 1, 2012 to June 30, 2012

The Florida Public Archaeology Network – Southeast (FPAN-SE) continues to expand outreach efforts as we begin our sixth year of operation. The April to June Quarter has evolved through time into a slightly slower quarter; we do not have our Graduate Student Assistants and the economic downturn has slowed summer camps in our region. Nevertheless, we introduced over 4,400 people to FPAN and its goals through lectures, meetings, events, and youth education opportunities. We had contact with the county archaeologists in all of our counties, and we are working with several local governments on specific preservation-focused ordinances and projects. Finally FPAN-SE was honored to receive the 2012 Judge L. Clayton Nance Award from the Broward County Historical Commission.
